Policies and Procedures

Rain Policy or Inclement Weather

- UNLESS the golf course is closed and deemed to be unplayable, the outing will proceed as scheduled.
- If the course is deemed to be closed prior to the start of the outing, the outing will have an option of establishing a rain date, or, receive rain checks for each participant.
- Hawk's Tail Staff will monitor weather conditions and make decisions based on the safety of the outing participants. In the event that less than 9 holes are played, and it is deemed the outing will not continue, the outing will have the option of receiving 9-hole rain checks or adding to its prize fund in an amount equivalent to 50% of the golf fee being charged.
- If the outing is cancelled before it starts due to inclement weather, the outing will be responsible for any meals that have been booked. Hawk's Tail will do everything possible to expedite the execution of the meal for the convenience of the outing within reasonable expectations.

Payment of Final Outing Invoice

- This is due on the day of the outing. Failure to do so will result in a 15% penalty.
- Accepted Payment Methods are as follows: Cash, Check or Credit Card. (Visa, Master Card, Discover, and American Express are accepted with a 3% up charge for merchant's fees.)

Food and Beverage Guidelines

- Hawk's Tail will require a minimum food and beverage count seven days prior to the outing and a final number within 48 hours.
- Hawk's Tail has a recognized Indiana Alcohol Beverage License; therefore, outside liquor is prohibited by the State of Indiana.
- On a limited basis, Hawk's Tail may allow charitable outings to have non-alcoholic drinks to be donated. Unless otherwise agreed upon, all donated products must be removed at the conclusion of the event with the supervision of a Hawk's Tail staff member.

Other Policies at Hawk's Tail GC

- Any golf car or property damage caused by participants or event staff shall be the responsibility of the event and will be billed accordingly. The outing agrees to indemnify and hold harmless Hawk's Tail Golf Course as well as its employees from any liability arising in negligence from the outing and its participants.
- Hawk's Tail is not responsible for damages or loss of any items which are stored at the course prior to the outing. You must receive permission from Shelly Gilaspy, Brandon Morton, or Scott Markle to store anything at the course. Hawk's Tail reserves the right to request bonding or proof of insurance at any time.
- Tax Exempt organizations must supply approved documentation by the State of Indiana at least 14 days prior to event.
- Illegal activities on Hawk's Tail Golf Course property is prohibited at all time.

Miscellaneous Information

- To help you better organize your event, Hawk's Tail Golf Course asks to receive a complete player list at least 48 hours before event. Last minute changes are permissible, and we will accommodate your needs. This will allow us to prepare accurate information on cart signs and scorecards. Hawk's Tail will provide you with a registration form to assist you in the process.
- Hawk's Tail will provide custom score sheets and will take care of scoring for all outings in excess of 24 players.
- Use of Hawk's Tail Golf Course's logo, photographs of the course, or any likeness of our facility must be pre-approved by Hawk's Tail Management.
